Appellee Alton Young sued appellant Lola Allen for fraud and obtained a default judgment against her in the amount of \$16,000. Appellee then sued appellant and her husband H. W. Allen for recovery of the same \$16,000 on a sworn account. Appellant answered, alleged the default judgment as a defense, and filed a cross-action against the Allens seeking a judgment against them for \$16,000 on a sworn account. Appellant filed a motion to consolidate the suit against her with the suit against the Allens, based on the pleadings, which was overruled. Appellant now brings two points of error contending that the judgment should be reversed and rendered on the grounds that the trial court erred in failing to grant a motion for consolidation and in failing to transfer the case. We affirm. The Allens filed their petition in the District Court of Dallas County on May 11, 1976. Appellant's cross-action was filed in the same cause in the same court on June 9, 1976. The cross-action named appellant as the defendant and H. W. Allen and T. D. Allen, the Allens' son, as additional defendants. T. D. Allen had not been served and the default judgment awarded to appellee was only against appellant. Appellant's cross-action also sought judgment against all defendants for \$16,000 on a sworn account. Appellant's answer in the district court alleged that the default judgment against her was void and that the judgment should be set aside and that H. W. Allen and T. D. Allen were discharged and released from any liability in the suit because no judgment had ever been rendered against them. She alleged that the trial court denied the motion to consolidate and transfer, and this is the basis of her first and second points of error. The motion to consolidate and transfer was sworn and was filed on June 16, 1976. The transcript, however, does not contain the order
